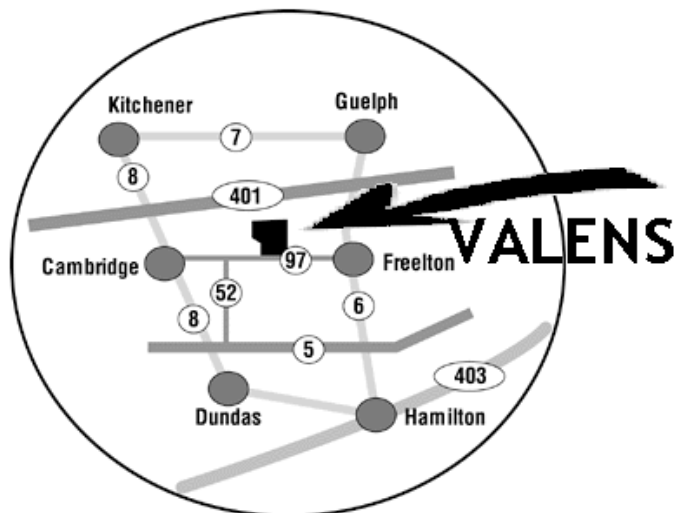


**HEADQUARTERS:** Powell Pavilion, inside Valens Conservation Area. Watch for signs!

Excerpt from CKC Rules & Regulation for Working Certificate Tests and Hunt Tests (sections 14.7 and 18.7 respectively)

It shall be the duty and obligation of the test-giving club to see that a judge, club official, volunteer, or any participant at an event held under these rules, is not subject to indignities of any kind. The Test Committee Chair shall promptly report to the CKC any infringement of this regulation, and the Discipline Committee shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred.
